Club West—A property management company and a developer negotiate, in the shadow of escalating legal fees and a trial, the fate of a deposit in escrow after the deal has gone sour. Negotiation simulation designed to demonstrate egocentric bias and escalation of commitment.

Jester Company—A small, family-owned publisher attempts to negotiate purchasing terms with a wholesale distributor. An exercise in integrative bargaining and persuasion through writing.

Pass/Fail—An entrepreneur specializing in test-preparation materials for clinical psychology licensing exams attempts to sell his business to a large competitor. An exercise in value creation and contingent contracts.

NML Pharm—A small pharmaceutical company announces a revolutionary new AIDS drug, but their partner conducts independent tests casting doubt on the drug's effectiveness. Designed to demonstrate the effect of partitioning events on students' judgment of probabilities.
